**Stud Dog Class** will be for Stud Dogs and two of their Get. Stud Dogs must be entered in the Stud Dog class and must be shown in the right with their Get. Owner of the Stud Dog need not necessarily be owner of Get. Get only to be judged, based on the merits of the Get. An entry fee of \$30.00 will be charged for each Stud Dog if he is not entered in any Regular class, Best of Breed Competition or other Non-Regular Class. If he is entered in another class the fee is \$15.00 and should be indicated in the "Additional Class" space of the entry form.
